मैं संघ से जुड़े सभी समिति की सभी सदस्यगण, कार्यकारिणी सदस्या, सुपरवाईजर एवं संघ और समिति के सभी कर्मचारियों का धन्यवाद व जोहार करती हूँ, मैं आज इस मंच से हमारी संस्था से जुड़े सभी सप्लायर, बायर, एवं स्टोक-होल्डर को भी धन्यवाद देती हूँ जिनका सहयोग हमें परस्पर मिल रहा है।

यह आप सभी की कड़ी मेहनत, लगन और सहयोग का परिणाम है जो कि आज हम सभी एकत्रित होकर यहाँ अपना सफल 20वीं वार्षिक आम सभा मना रहे हैं।

मैं आज इस मंच से कृषि निदेशालय, झारखंड सरकार, कृषि पशुपालन एवं सहकारिता विभाग, को तहे दिल से धन्यवाद देती हूँ जिन्होंने समितियों के बेहतर कार्य को देखते हुए संघ से जुड़े तीन समितियाँ (लोहरदगा, गुमला, एवं पोटका) को 15 लाख रुपए FPO Equity ग्रांट के रूप में दिया है। साथ में यह भी निश्चित किया गया है कि अगर समितियाँ ऐसे ही अच्छे से कार्य करते रहेंगे और समितियों का व्यापार बढ़ता रहेगा तो आगे भी सभी समितियों को सहयोग मिलता रहेगा।

मैं आप सभी के समक्ष वित्तीय वर्ष 2024-25 का, संघ की वार्षिक प्रतिवेदन प्रस्तुत कर रही हूँ, मैं आप सभी का ध्यान अपने संस्था की ओर आकर्षित करना चाहती हूँ, आज हमारी संस्था झारखण्ड महिला स्वावलम्बी पोल्ट्री सहकारी संघ लि०, के अंतर्गत 9 सहकारी समितियाँ कार्यरत है, इन समितियों में 8 सहकारी समितियाँ ब्रायलर उत्पादन एवं 1 सहकारी समिति कॉमर्शियल अंडे के उत्पादन का कार्य करती है। इनमें से प्रत्येक समिति एक स्वतंत्र इकाई है जो अपने सदस्यों को इनपुट आपूर्ति, उत्पादन सहायता, एवं ब्रायलर बर्ड्स एवं अंडे की बिक्री का कार्य करती है, ये सभी सहकारी समितियाँ संघ के शेयरधारक हैं। वर्तमान में संघ, पूर्वी भारत की महिलाओं द्वारा संचालित सबसे बड़ी पोल्ट्री उत्पादन संगठन है। इन सभी समितियों को मिलाकर हमारा संघ 5600 से अधिक महिलाओं का संगठन है।

आज के दिनों में संघ 50,000 क्षमता का पैरेंट फार्म, एवं 6 लाख चिक्स प्रतिमाह उत्पादन की हेचरी का संचालन स्वयं करती है, तथा ब्रायलर मुर्गियों के लिए औसतन 1300 मेट्रिक टन प्रतिमाह पैलेटेड फीड का उत्पादन करती है, इन प्लांटों में उत्पादित दाना एवं चूजों की गुणवत्ता अन्य की तुलना में बेहतर रहती है, जिनकी आपूर्ति समिति के मांग के अनुसार की जाती है, साथ में सभी समितियों का मुर्गीपालन से जुड़े सभी तरह का सामग्री क्रय करने में मदद करती है एवं तैयार मुर्गा एवं अंडे के बेहतर दर में बिक्री के लिए बाजार खोजने में सहयोग करती है। संघ की मुख्य भूमिका बैकवर्ड और फॉरवर्ड लिंकेज स्थापित करके समितियों को मजबूती प्रदान करना है। व्यापार के अलावा संघ अपने समितियों को तकनीकी, प्रबंधकीय, वित्तीय एवं वैधानिक सहायता सुनिश्चित करती है।

संघ द्वारा वर्ष 2024-25 में किये गए कार्य :

- संघ के 8 ब्रायलर उत्पादन समितियों के द्वारा कुल 10012.62 मेट्रिक टन ब्रायलर मुर्गियों का उत्पादन किया गया, जिसका विक्रय मूल्य 102 करोड़ 10 लाख रहा।
- संघ के लेयर समिति (GAUS) में 1 करोड़ 98 लाख कमर्शियल अंडों का उत्पादन हुआ, जिसका विक्रय मूल्य 10 करोड़ 56 लाख रहा।
- 9 समितियों के द्वारा कुल 112 करोड़ 95 लाख रुपये का व्यवसाय किया गया।
- समितियों द्वारा उत्पादक सदस्यों को 8 करोड़ 80 लाख ग्रावर चार्ज का भुगतान किया गया।
- संघ के ब्रीडर यूनिट में 30 लाख 32 हजार हेचिंग अन्डो का उत्पादन हुआ।
- पेटरवार में स्थित हेचरी में 42 लाख 59 हजार ब्रायलर चिक्स का उत्पादन हुआ।
- ब्रायलर बर्ड्स के लिए 14950 मेट्रिक टन दाना का उत्पादन किया गया।
- संघ ने वर्ष 2024-25 में रु 84 करोड़ 15 लाख का व्यवसाय किया एवं टैक्स नियोजन के उपरांत संघ का शुद्ध लाभ 13.68 लाख रुपया रहा।
- संघ के वित्तीय वर्ष 2024-25 का अंकेक्षण SK Jha & Associates, CA Rajiv N Choudhary द्वारा किया गया है।

वित्तीय वर्ष 2024-25 में हमारी 8 ब्रायलर समितियों में 5 समिति (गुमला, पेटरवार, लोहरदगा, दुमका एवं पोटका) लाभ में रही, बाकि 3 समितियाँ (तोरपा, पटमदा एवं गोड्डा) को व्यापार में नुकसान हुआ।

आप सभी को बताते हुए मुझे अत्यंत प्रसन्नता हो रही है की संघ द्वारा संचालित बसिया लेयर समिति जिसमे लगातार कुछ वर्षों से नुकसान हो रही थी, वहां के सदस्यों की मेहनत और संघ एवं समिति के अथक प्रयास से वह समिति विगत 2 वर्षों से लाभ में हैं, वित्तीय वर्ष 2024-25 में समिति को 48 लाख 86 हजार रुपये का शुद्ध लाभ हुआ और अंडा उत्पादन में सदस्यों को 68 लाख 54 हजार रुपये ग्रावर चार्ज भी मिला जिसमे अतिरिक्त ग्रावर चार्ज के रूप में 3 लाख 96 हजार रुपये पहली बार समिति के द्वारा सदस्यों को दिया गया।

अंत में मैं आप सभी का हृदय से आभार प्रकट करती हूँ और मैं अपनी वाणी को विराम देते हुए, पुनः संघ के सभी समितियों एवं उनकी सभी सदस्यगण और हमारी संस्था से जुड़े सभी स्टैक-होल्डर का सादर जोहार करती हूँ।

Overview

Registered on 31st March 2005 under the Jharkhand Self Supporting Cooperative Societies Act, 1996, JWSPCFL functions as a federation of primary-level poultry cooperatives across Jharkhand. It aims to achieve economies of scale in procuring inputs, ensure improved compliance, and provide access to professional and technical support. The federation also serves as a platform for knowledge sharing and process improvement among member cooperatives, fostering solidarity and ensuring competitiveness through adaptability to techno-commercial changes in the poultry industry.

Focus and Membership

JWSPCFL's core initiative empowers rural marginalized women in Jharkhand, who are smallholder poultry farmers engaged in primary cooperative societies. These women serve as both members and shareholders. The cooperatives are federated into state-level secondary organizations, amplifying their collective impact. With a strength of 5,675 women poultry producers, JWSPCFL sustains the largest organized poultry operations in eastern India.



Mission

To develop livelihood opportunities through rural poultry enterprises by standardizing the Smallholder Poultry (SHP) model, which offers significant potential for scaling and benefiting a large number of rural women in Jharkhand.



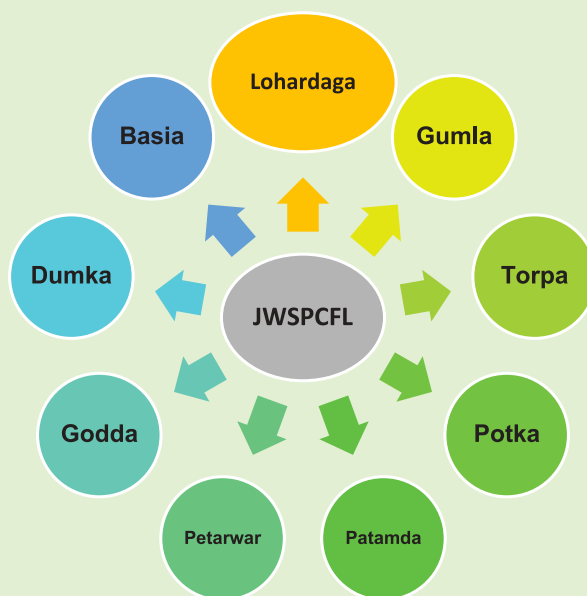
Vision

Governing Board of the Federation

The governing board of the Federation consists of five members, who are elected from among the member co-operatives of Federation. The elected directors and the representatives of the board conduct board meeting periodically. The board reviews and plans the operation of the Federation. They take decisions on the proposals, plans and budgets presented by the Chief Executive Officer/Unit Manager. The Board Members discuss the grievances and concerns of the co-operatives and take forward the key points of discussion and decision to the co-operatives.

KEY BUSINESS MODELS OF JWSPCFL

In order to assist the co-operatives in their business and develop the SHP Model in Jharkhand, it has been consistently working towards integration of backward and forward linkages. Presently the Federation owns a well-established backward linkage. The establishment of backward linkages for production helps to minimize the cost of production and ensures quality of input materials.

In FY 2024-25 a total number of **30,31,767** hatching eggs were produced and transferred to Petarwar hatchery for chicks' production.

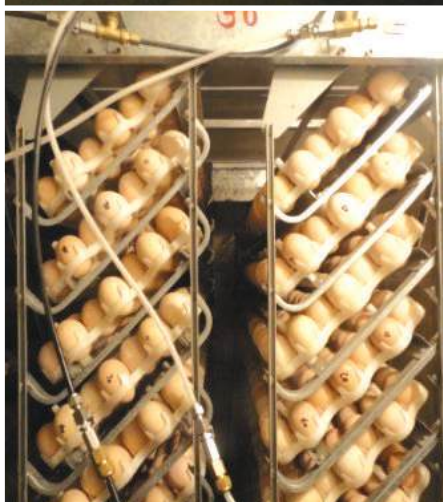
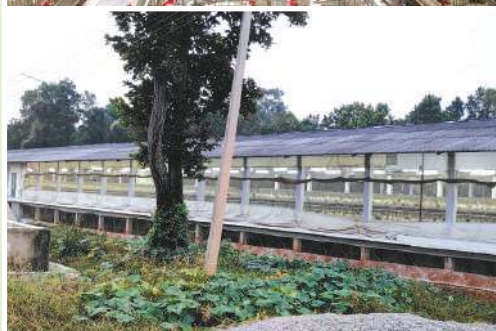
Capacity of producing 6 lakhs day old chicks (DOCs) per month.

During FY 2024-25, a total of **42,58,853** - day-old chicks were produced by the Federation and a sales turnover of **Rs 17,45,12,031.00** (Seventeen Crore Forty-Five Lakh Twelve Thousand Thirty-one only) was generated.

Feed Mill of the Federation

The poultry feed accounts for 70% of the total cost of production. The Federation operates feed mills at Nagri to cater the feed requirements of broiler units.

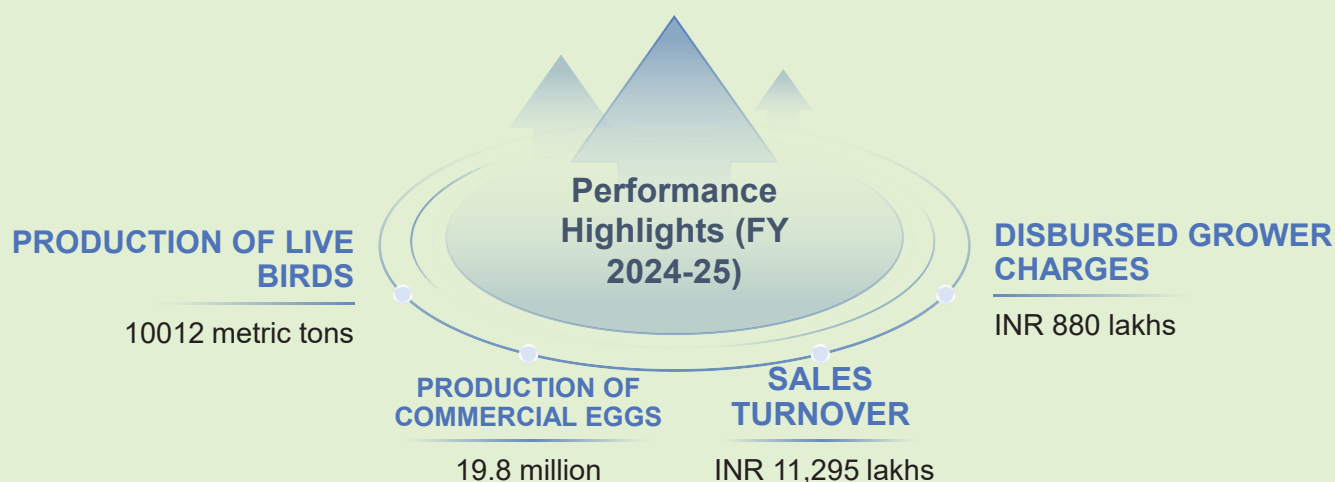

The Federation provides following supports to member cooperatives to fulfill its mission:

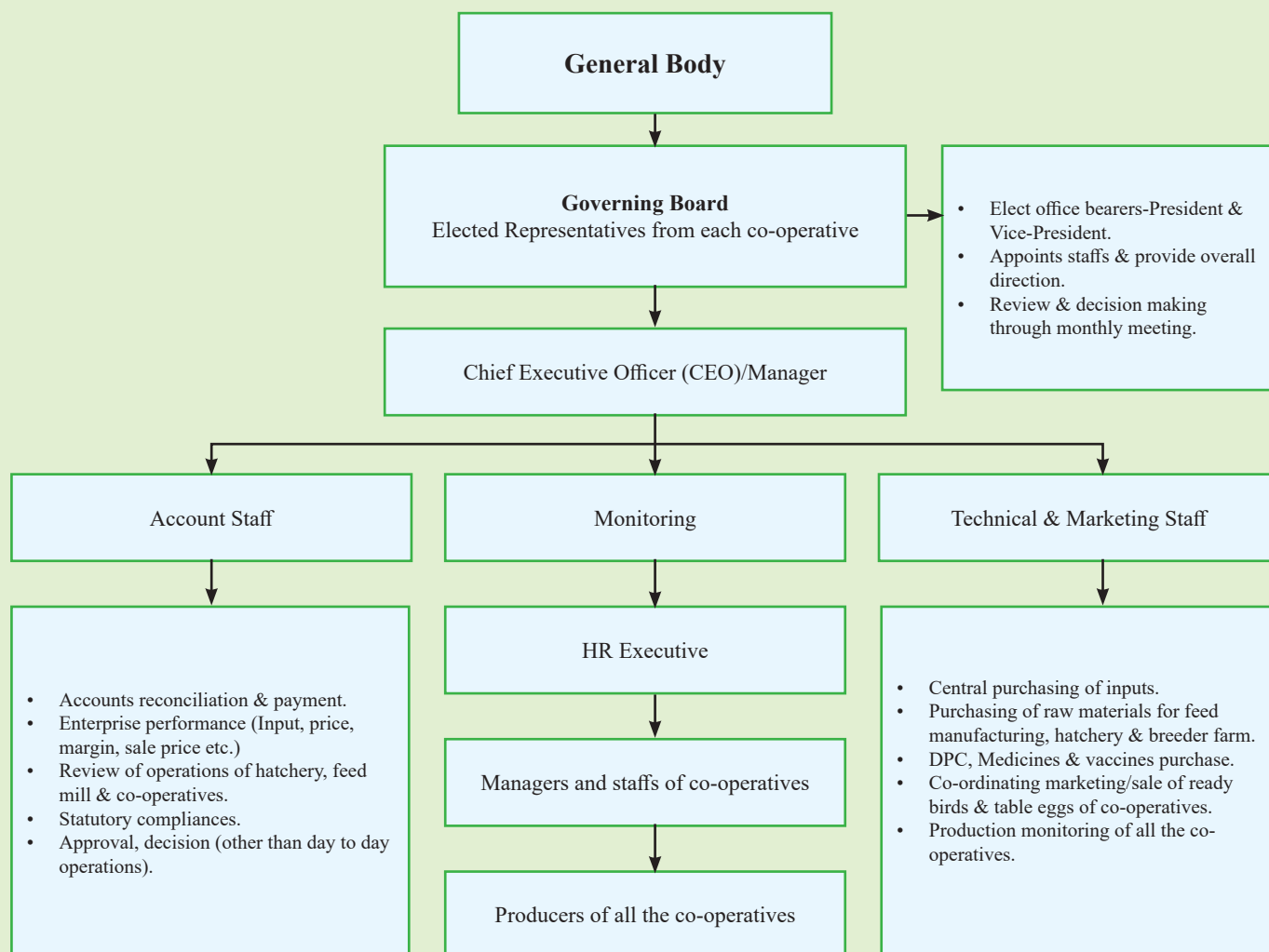
1. **Input linkages:** - The Federation has established backward integration facilities like breeder farm, hatchery & feed plant to supply quality chicks & feed to the collectives. Bulk procurement of medicine, vaccine, equipment's & ensuring quality raw materials at best prices is also the critical function of state federation.
2. **Techno-Managerial Support:** - Organizes training for producers and cooperative staff, provides trained professionals for managerial positions of cooperatives
3. **Financial & statutory Services:** - Mobilizes fund & working capital for new project and activity, conducts internal audits, ensures adherence to regulatory & statutory compliances.
4. **Marketing linkages:** - State federations have established dedicated marketing cell in their respective states to support the producer collectives in establishing market linkages and brand development.

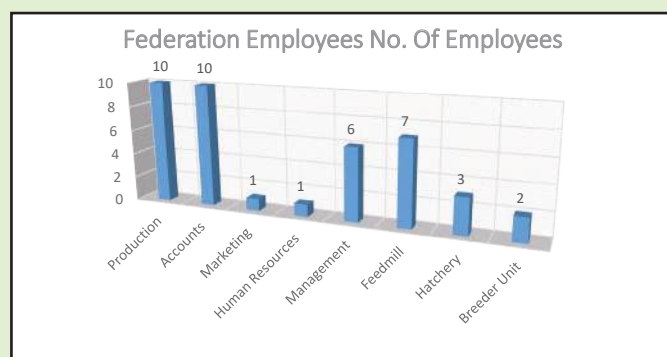


Organisational Structure in the context of Federation



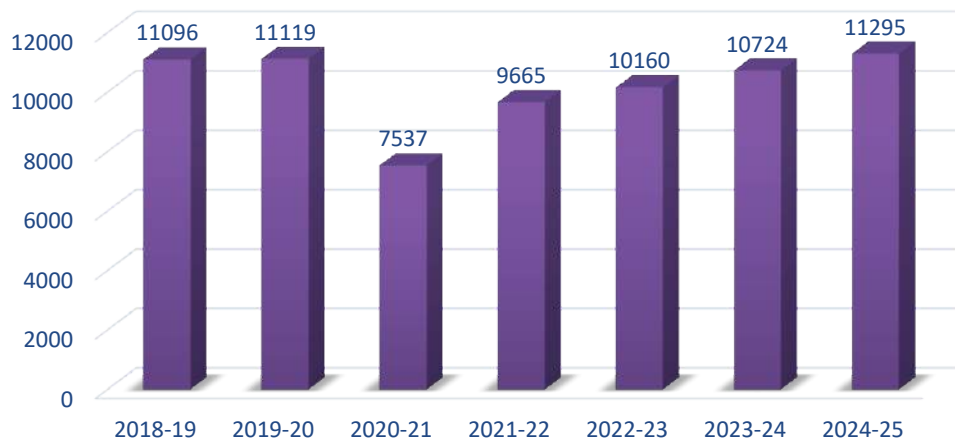
Human Resource

Coperative Sales Turnover



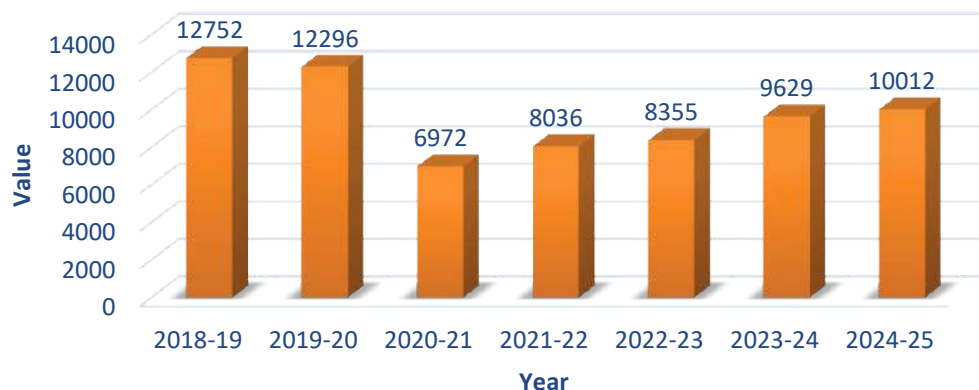
Federation Sales Turnover Value

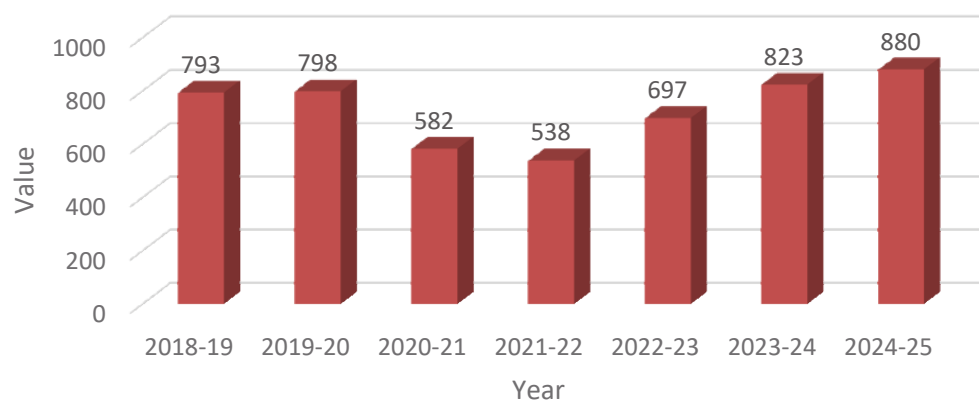

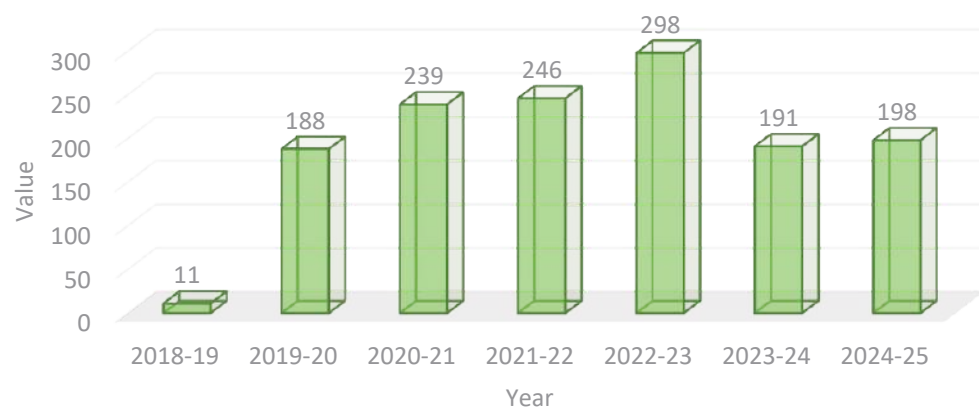



Farming Success Stories: Innovators and Leaders

Resilient Farmer – Rita Devi

Rita Devi, wife of Ramlal Ram, from Gopitoli village, Kuru block, faced many struggles after marriage as her husband worked as a daily labourer far from home, while she also did labour work and sold firewood to manage household expenses. With limited farmland, it was difficult to feed the family and educate the children.

In 2012, she joined the Lohardaga Grameen Poultry Cooperative Society Ltd. and started poultry farming with a 500 sq. ft. shed. Over the years, she gradually expanded it to 1500 sq. ft. and in 2024–25 earned about ₹1,45,064 from poultry alone.

Through poultry farming, Rita Devi improved her family's income, bought farmland, ensured good education for her children, and provided better living conditions. Today, her family lives a happy and secure life, and she feels proud of her journey from hardship to self-reliance.

A Journey of Empowerment: Chandmuni Devi's Story

In 2003, I was married to my husband, Baleshwar Manjhi. I never had the opportunity to pursue my own education, yet I was determined to give my children the future I once dreamed of. Today, my elder daughter is studying for her B.Com degree in Hazaribagh, and my son is in Class 8. Every step forward for my family has been possible because of my work in poultry farming.

In 2007, I became a proud member of the Peterwar Gramin Poultry Swawlambi Sahkari Samiti Limited. With government support, I was given a poultry shed with a capacity of 300 birds. That was the beginning of my journey. In the initial years, my annual income ranged from just ₹10,000 to ₹15,000. But I was determined. I saved diligently, reinvested my earnings, and with the support of the cooperative's advance facility, I gradually expanded my capacity to 2,000 birds.

As the years went by, my income steadily increased. This year alone, I raised five batches of poultry and earned a total income of ₹1,37,789. My husband stands firmly by my side in this journey. While I manage poultry farming, he uses the poultry litter as fertilizer in our fields, which has significantly boosted our agricultural yield. Together, we have been able to repair our home, provide education to our children, and build a better life.

From Migration to Self-Reliance: Dumka's Poultry Project (JOHAR Yojna) Success

The Small Holder Poultry Model, implemented in Dumka district through a collaboration between JWSPCFL and JSLPS under the JOHAR Yojna, enables rural women to earn INR 35,000–40,000 annually by managing 500-bird poultry sheds in their backyards.

The project supports women with chicks, feed, medicine, technical guidance, and marketing, while requiring only 2–3 hours of daily effort.

A powerful example is Sarita Murmu of Rampur village, a widow who overcame hardship after her husband's death. With project support, she built a poultry shed, now earns INR 12,000–15,000 per batch, provides education for her children, purchased a scooty, and is constructing a pucca house. Her journey from struggle to self-reliance has inspired other women in her village.

The initiative has been transformative—empowering women, reducing migration, and improving socio-economic conditions in rural Jharkhand.

Shobha Devi's Journey from Struggles to Success

Shobha Devi once lived in deep uncertainty. After her father-in-law's death, the family broke apart, leaving her and her husband with no support, little land, and no steady income. With no jobs and children to raise, she even considered migrating to work in a brick kiln.

In 2006, everything changed when the Gumla Gramin Poultry Cooperative Society introduced poultry farming in her village. Motivated by the training and support provided, Shobha started with a small 500-bird shed. To her surprise, poultry farming not only brought regular profits but also dignity and respect in her community.

Encouraged, she reinvested her earnings, built another farm of her own in 2016, and expanded to 1,000 birds. Today, Shobha earns nearly ₹1.8 lakh annually, has bought a scooter, built a pucca house, and most importantly, educated her children successfully. She also took on the role of Supervisor in the cooperative, where she was honored as an “Outstanding Supervisor.”

- Shobha proudly says: “My progress and respect are all because of poultry farming. It gave me independence, dignity, and a bright future for my family.”

Eggs of Hope: The Journey of Nirmala Indwar

Nirmala Indwar from Kumhari Gartoli, Gumla, once struggled with her family on just one acre of land and had to migrate with her husband for daily wage work. Despite hard labor, they barely managed to survive.

Her turning point came in 2016 when she learned about the poultry cooperative under the Jharkhand Women's Self-Supporting Poultry Federation. With support from JSLPS's JOHAR project (₹1,20,000 grant) and a ₹40,000 loan, she built her own poultry shed. By 2019, she started egg production and also took on the role of Village Supervisor, guiding 16 other poultry farmers.

Today, she earns ₹7,000–₹8,000 per month (from eggs and supervisory work combined), built a new house, sends her children to good schools with private tuitions, and no longer depends on loans.

Nirmala dreams of giving her children higher education, saving for the future, and helping fellow members grow. Her resilience and leadership have made her a role model in the cooperative movement.
