

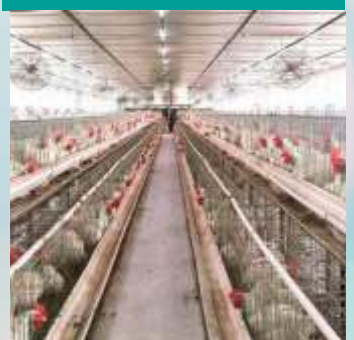

मैं पूर्णिमा देवी, अध्यक्ष झारखंड महिला स्वावलम्बी पोल्ट्री सहकारी संघ लि०, की ओर से संघ की 19वीं वार्षिक आम सभा में यहाँ उपस्थित सभी अतिथिगण को धन्यवाद व ज़ोहार करती हूँ। साथ ही आज मैं आमसभा की इस शुभ अवसर पर, झारखण्ड सरकार, कृषि, पशुपालन एवं सहकारिता विभाग, सभी जिला प्रशासन को धन्यवाद व ज़ोहार करती हूँ जिनका सहयोग हमें हमेशा मिलता रहा है।

मैं संघ से जुड़े सभी समिति की सभी सदस्यगण, कार्यकारिणी सदस्या, सुपरवाइजर एवं सभी कर्मचारियों का धन्यवाद व ज़ोहार करती हूँ, मैं आज इस मंच से हमारी संस्था से जुड़े सभी बायर, सप्लायर, एवं स्टेक-होल्डर को भी धन्यवाद देती हूँ जिनका सहयोग हमें परस्पर मिल रहा है। यह आप सभी की कड़ी मेहनत, लगन और सहयोग का परिणाम है जो आज हम सभी एकत्रित होकर यहाँ अपना सफल 19वीं वार्षिक आम सभा मना रहे हैं।

मैं आप सभी के समक्ष वित्तीय वर्ष 2023-24 का, संघ की वार्षिक प्रतिवेदन प्रस्तुत कर रही हूँ, मैं आप सभी का ध्यान अपने संस्था की ओर आकर्षित करना चाहती हूँ, आज हमारी संस्था झारखण्ड महिला स्वावलम्बी पोल्ट्री सहकारी संघ लि०, के अंतर्गत 9 सहकारी समितियाँ कार्यरत है, इन समितियों में 8 सहकारी समितियाँ ब्रायलर उत्पादन एवं 1 सहकारी समिति कॉमर्शियल अंडे के उत्पादन का कार्य करती है। इनमें से प्रत्येक समिति एक स्वतंत्र इकाई है जो अपने सदस्यों को इनपुट आपूर्ति, उत्पादन सहायता, एवं ब्रायलर बर्ड्स एवं अंडे की बिक्री का कार्य करती है, ये सभी सहकारी समितियाँ संघ के शेयरधारक हैं। वर्तमान में संघ, पूर्वी भारत की सबसे बड़ी पोल्ट्री उत्पादन संगठन है। इन सभी समितियों को मिलाकर हमारा संघ 5000 से अधिक महिलाओं का संगठन है।

आज के दिनों में संघ 50,000 क्षमता का पैरेंट फार्म, एवं 6 लाख चिक्स प्रतिमाह उत्पादन की हैचरी का संचालन स्वयं करती है, तथा ब्रायलर मुर्गियों के लिए औसतन 1200 मेट्रिक टन प्रतिमाह पैलेटेड फीड का उत्पादन करती है, इन प्लांटों में उत्पादित दाना एवं चूजों की गुणवत्ता अन्य की तुलना में बेहतर रहती है, साथ ही हमारे संघ द्वारा उत्पादन की हुई दाना का दर, बाजार के दर से 1 से 2 रुपया प्रतिकिलो कम रहता है, जिनकी आपूर्ति समिति के मांग के अनुसार की जाती है। साथ में सभी समितियों का मुर्गीपालन से जुड़े सभी तरह का सामग्री क्रय करने में मदद करती है एवं तैयार मुर्गा एवं अंडे के बेहतर दर में बिक्री के लिए बाजार खोजने में सहयोग करती है। संघ की मुख्य भूमिका बैकवर्ड और फॉरवर्ड लिंकेज स्थापित करके समितियों को मजबूती प्रदान करना है। व्यापार के अलावा संघ अपने समितियों को तकनीकी प्रबंधकीय, वित्तीय एवं वैधानिक सहायता सुनिश्चित करती है।

## About JWSPCFL

Jharkhand Women Self-Supporting Poultry Co-operative Federation Ltd. (JWSPCFL) was registered on 31st March 2005 under Jharkhand Self Supporting Cooperative Societies Act 1996, as a Federation of primary level poultry co-operatives in Jharkhand. The purpose was to attain economies of scale in procuring inputs, improved compliance and access to professional and technical support, while providing a platform for sharing knowledge and process among member cooperatives and building solidarity. The Federation ensures that cooperatives remain competitive, adapting and responding to techno-commercial changes in the industry.

This entire initiative is centered on the rural marginalized women in Jharkhand, who are engaged as small holder poultry farmers in the primary level co-operatives. These women poultry producers are the members as well as the shareholders of the co-operative and the cooperatives are further Federated into state level secondary organizations.

Presently, the Federation has 9 member co-operatives with operations spread over Kuru (Lohardaga), Gumla, Torpa(Khunti), Potka (East Singhbhum), Patamda (East Singhbhum), Petarwar (Bokaro), Godda, Dumka and Basia (Gumla). The board of directors of the federation are elected from the chairperson of the member co-operatives. At this scale, the Federation sustains the largest organized poultry operations in eastern India with 5679 women poultry producers.

During FY 2023-24, these women produced 9,629 MT of live birds and 189 lakhs commercial eggs registering a sales turnover of INR. 10,723 lakhs and disbursed a total grower charge of INR. 823 lakhs.

### Mission

The mission of the organization is to develop livelihood opportunities based on rural poultry enterprises, standardization of the smallholder poultry (SHP) model that offers enormous scope for further expansion of the activity to benefit large number of rural poor women in Jharkhand.

### Vision

To establish a strong institution of poultry enterprise run by rural marginalized women for generation of sustainable source of income.

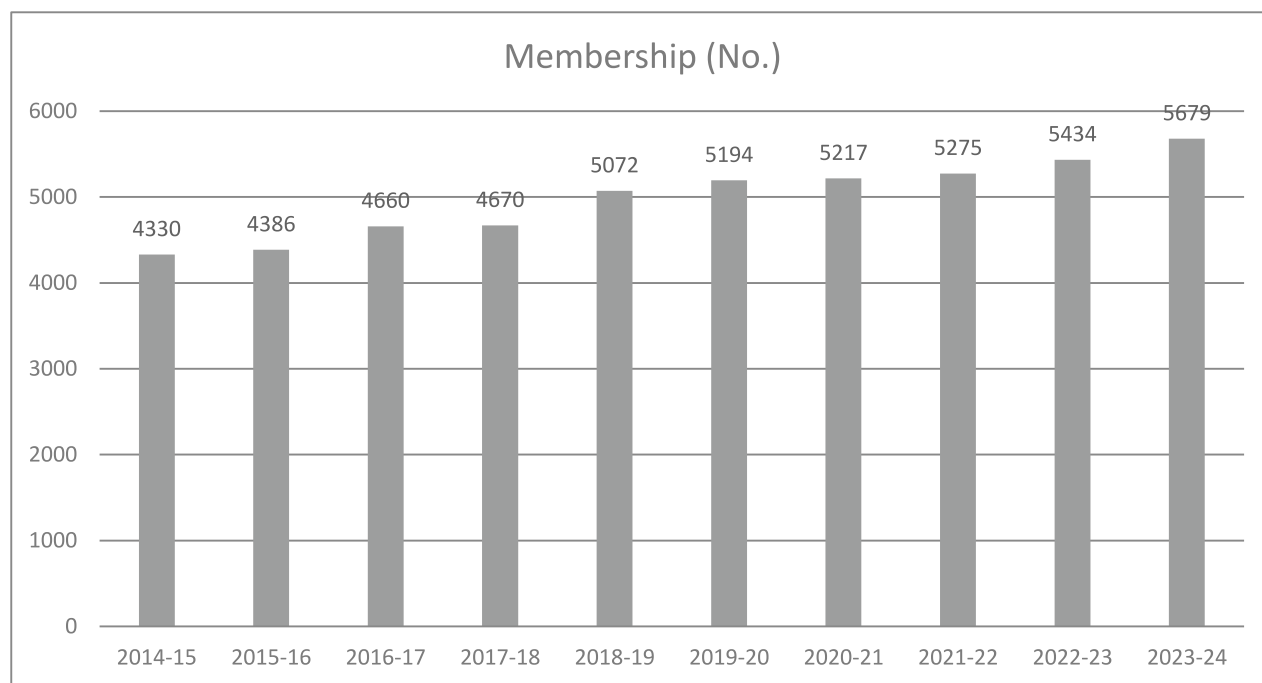

These co- operatives have the capacity to rear approximately 90 lakhs birds annually with the production volume of more than 10,000 metric tons of live birds per annum and can register a sale of more than 40 metric tons per day. This volume of business is one of the highest in Jharkhand by any private entity. However, in FY 2023-24, the co- operatives could rear only 56 lakhs chicks due to working capital shortage resulted from impacts of COVID19 pandemic.

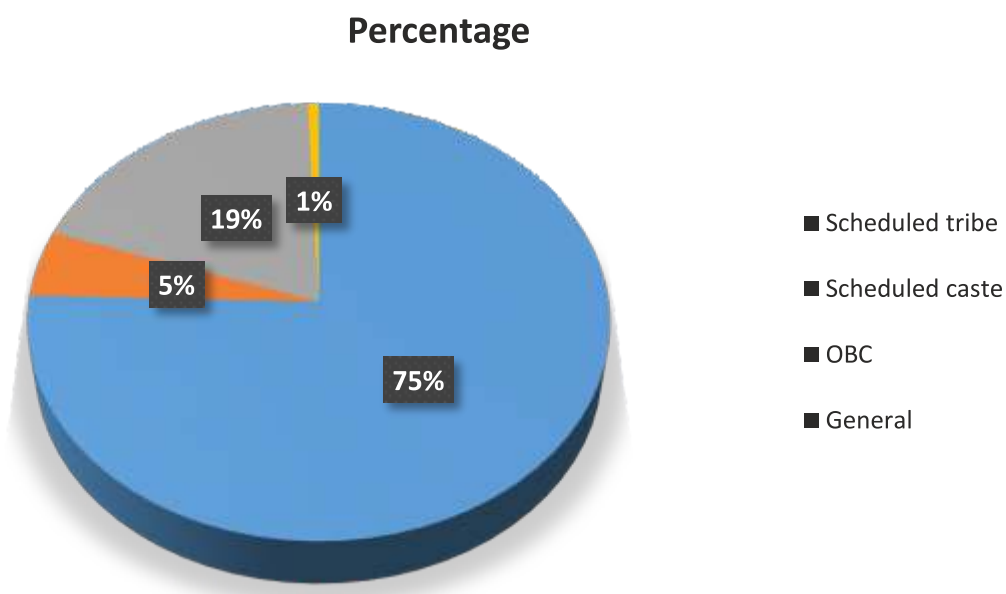

### Total No. of Member till now

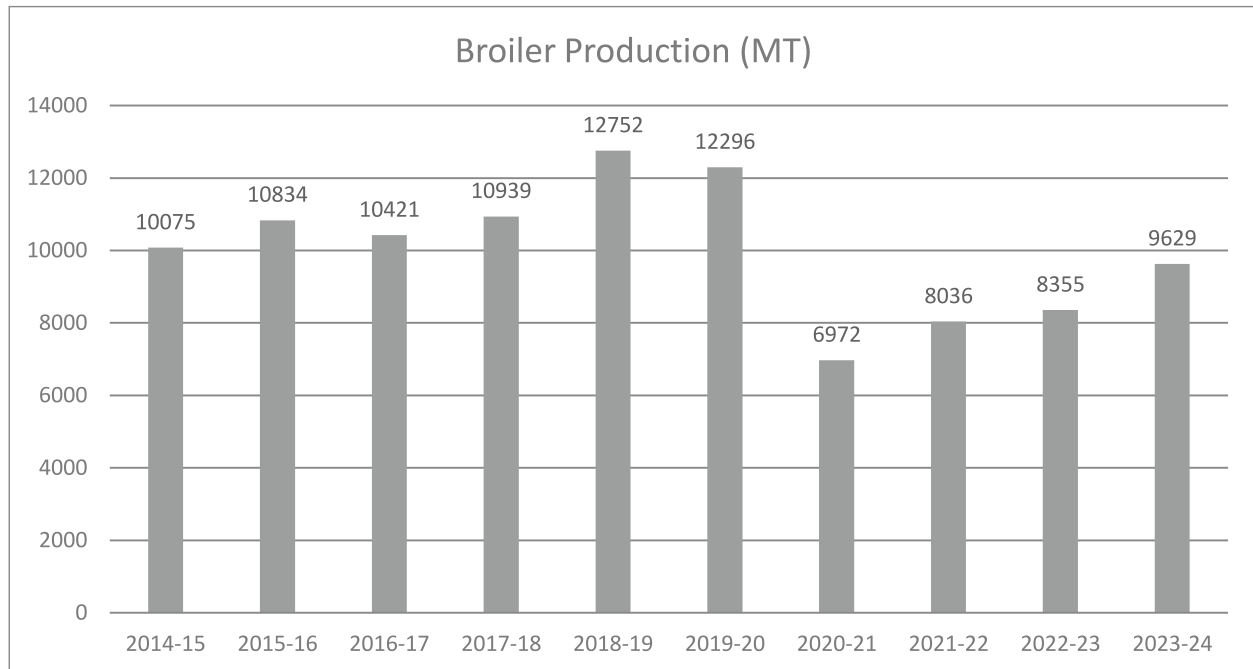


### Membership Profile

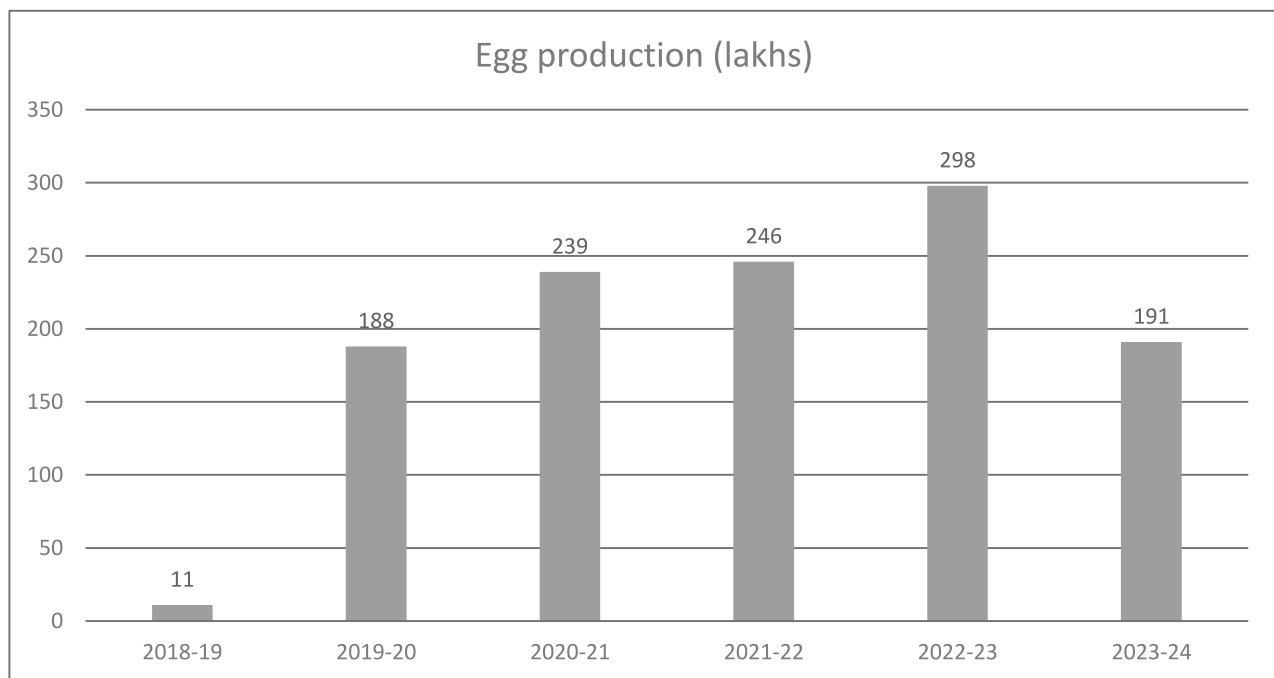


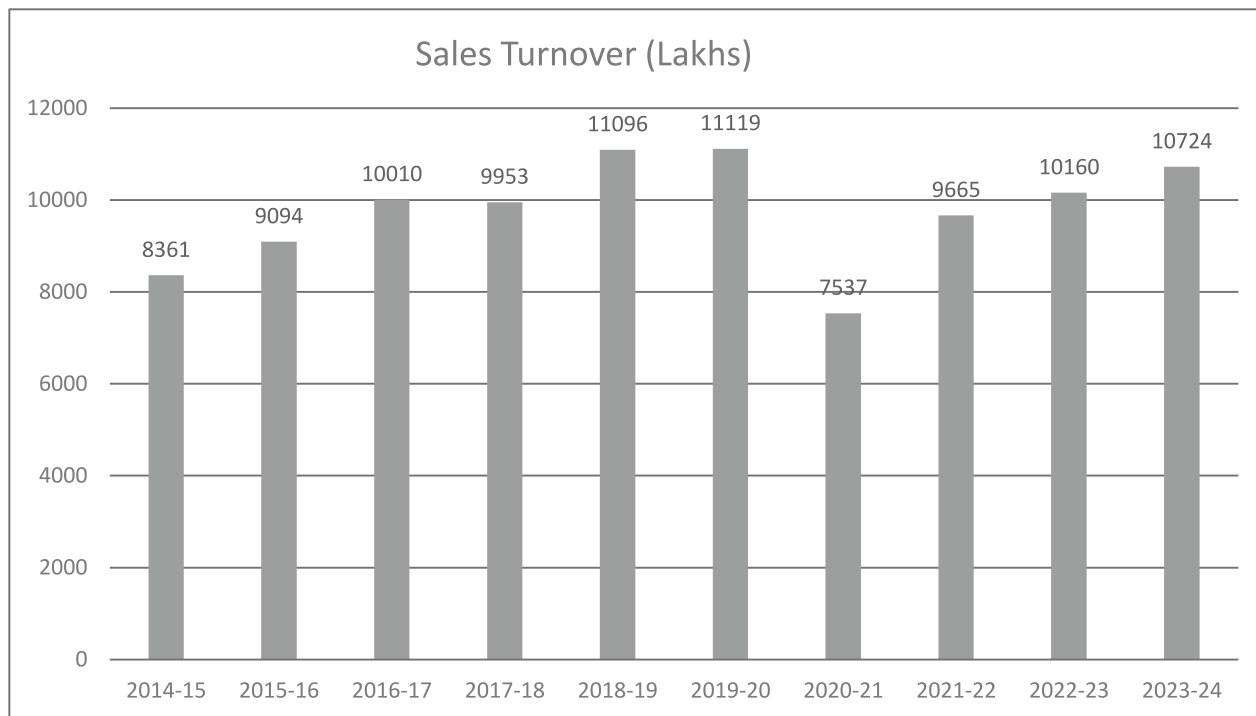
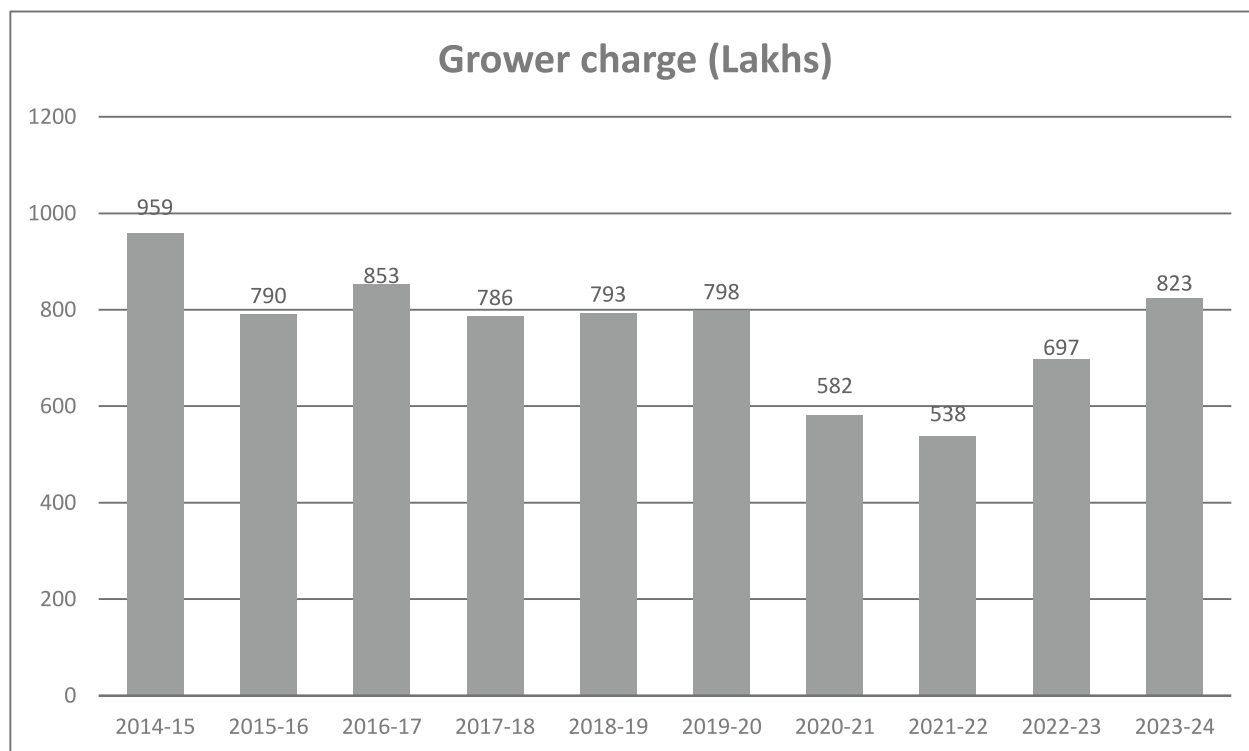


## **Broiler Production**

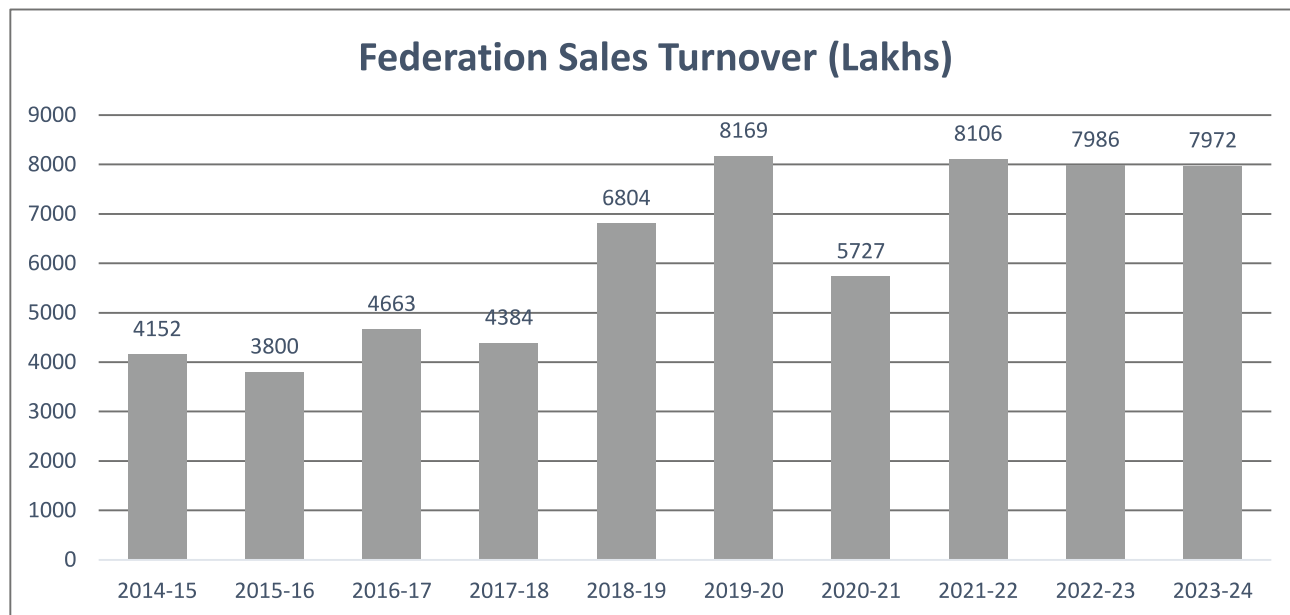


## **Eggs Production over the years**

## Governing Board of the Federation

The governing board of the Federation consists of five members, who are elected from among the member co-operatives of Federation. The elected directors and the representatives of the board conducts Board Meeting periodically. The board reviews and plans the operation of the Federation. They take decisions on the proposals, plans and budgets presented by the Chief Executive Officer/Unit Manager. The Board Members discuss the grievances and concerns of the co-operatives and take forward the key points of discussion and decision to the co-operatives.

The present Board of the Federation was formed by the election held on 22<sup>nd</sup> August, 2022. The list of board directors are as follows:

## **Governance**

The Co-operatives and Federation are governed by the Governing Board. In the co-operatives the Governing Board is elected from among the members. The Governing Board consists of 11 to 21 members depending upon the bye-laws of the co-operatives. A president and Vice-President are elected amongst them. The duration of the Board is of five years. They meet periodically to review and plan the business of co-operatives. The Board Members represent their respective villages and clusters hence it is their responsibility to disseminate the decisions of the Governing Board to all the members and to bring the grievances and concerns of the members to the Governing Board.

Through the Governing Board the power of governance lies in the hands of the members and ownership is built by taking responsibility and accountability of the enterprise.

## **Business of the Federation**

In order to assist the co-operatives in their business and develop the SHP Model in Jharkhand, it has been consistently working towards integration of backward and forward linkages. Presently the Federation owns a well-established backward linkage. The establishment of backward linkages for production helps to minimize the cost of production and ensures quality of input materials.

The parent farm and hatchery operation of the federation produces day old chicks and feed mill operation produces ready feeds for its member co-operatives.

The co-operatives procure inputs such as day-old chicks, feed, medicine, vaccine etc. and supplies to the members. The members rear birds at their shed and the ready birds are sold to the wholesale buyers from the member's shed. A proper Quality Management System is in place to eliminate unnecessary activities and maintain transparency.

### **Broiler Breeder Parent Farm**

The Federation has established a Broiler Breeder Parent Farm of 50,000 capacities at Gumla, out of which 20,000 capacities established with financial assistance from RABO Bank, The Netherlands. Another Parent Farm of 30,000 capacities is being constructed under financial assistance from Department of Animal Husbandry, Government of Jharkhand.

The production details of Broiler Breeder Parent Farm are as follows:

In FY 2023-24 a total number of 50,14,045 hatching eggs were produced and transferred to Petarwar hatchery for chicks' production.

### **Hatchery at Peterwar and Lohardaga**

The Federation operate a hatchery at Peterwar block of Bokaro, the hatchery at Peterwar is operational since 2011 and it has a capacity of producing 6 lakhs day old chicks (DOCs) each per month.

During FY 2023-24, a total of **46,09,505-day-old** chicks were produced by the Federation and a sales turnover of **Rs 15,78,14,923.00** (Fifteen lakh seventy-eight thousand nine hundred twenty-three only) was posted.

### **Feed Mill of the Federation**

The poultry feed accounts for 70% of the total cost of production. The Federation operates feed mills at Nagri to cater the feed requirements of broiler units.

### **An Inspiring story of**

#### **BASANTI DEVI**

Gopitoli, Kuru,  
Lohardaga, Jharkhand

Basanti Devi, a member of Lohardaga Grameen Poultry Co-operative society since 2007 was working as a labour in brick kiln with her husband to run her family. It was an arduous task for her to raise her children with the low meagre of money she was receiving from her work.

It was then she was informed that women from her neighbour village were rearing poultry and earning money without even having to leave their house which was a driving force for her to think about rearing poultry as a good option for earning money to run her family. She then attended meeting regarding construction of poultry sheds conducted by officials of Lohardaga Grameen Poultry Co-operative society.

This meeting bought a flicker of hope as she decided to construct a poultry shed under RSVY scheme. In 2007 she started rearing of birds with 300 sq.ft. capacity of shed which she later on extended to 1500 sq.ft. with a personal loan of 1,18,000 rupees in 2017-2018 which she already paid back by 2021 and now earning a good amount of near about a Lakh of rupees per year from only rearing poultry in her backyard by which she is soon to become a 'Lakhipati kisan'.

Her courage with her perseverance to make her child's life brighter made her a self-reliant independent woman. Today one of her child has completed his graduation & preparing for his post-graduation, other one is studying in ITI & the youngest one is doing his graduation from a good college in Ranchi. With her earnings from poultry she is able to give herself a good life, a house, a bike to her husband along with good education to her children.

Poultry rearing has led to her financial stability and has given her a dignified life and she has become an example and inspiration for everyone in her village.





## **IF THERE IS A WILL THERE IS A WAY**

### **BHINSARIYA DEVI**

Nawadih, Kuru, Lohardaga, Jharkhand

Bhinsariya Devi, a hard working member of Lohardaga Grameen Poultry Co-operative society since 2004 hailed from a poor needy family who had to amputee her right hand during an accident when she was only 16 years old of age.

She got married to a disabled man who couldn't work for his livelihood other than helping her in agriculture.

It was after the death of her husband in 2003 when she was burdened of how to earn her bread and raise her kids. She got to know about poultry rearing in neighbour villages by Lohardaga Grameen Poultry Co-operative society and regarding construction of poultry sheds under RSVY scheme. After which to satiate her family's hunger she decided to construct poultry shed and started rearing birds 'SINGLEHANDEDLY'.

Since then she has been rearing her birds with her only hand and doing pretty well. Her courage and strong determination helped her to have financial stability, a better and secured life for her and her children. She is now able to help with the education of her grandchildren. She is a perfect example of "If there is a Will there is a Way"

**Dorothi Khariyan, Sonmer, Basia, Gumla**






Mrs. Dorothi Khariyan, a resident of Sonmer, Basia, Gumla, faced significant financial struggles before joining the Grameen Anda Utpadak Swawlambi Sahakari Samity Ltd. in 2018. She and her husband, Mr. Sukra Tete, owned six acres of land where they grew paddy and vegetables, but the land was not very fertile, and their annual income from farming was insufficient, ranging between Rs. 30,000 to Rs. 50,000. To meet their family's needs, Mr. Tete migrated to other states like Goa, Punjab, and Chhattisgarh, where he worked as a carpenter, earning Rs. 7,000 to Rs. 10,000 per month. Despite this, their income barely covered essential expenses, and their son, who had completed the 12th grade, worked as a daily labourer in the village, earning Rs. 100 per day when work was available.



In 2014, Dorothi joined the Cham Mahila Mandal Self-Help Group (SHG). Through the SHG, she learned about the Jharkhand Women's Self-Supporting Poultry Co-operative Federation Ltd., which planned to start a poultry cooperative in Basia Block. Seeing the potential, Dorothi became a member of the cooperative when it was officially registered in 2018.

With loan assistance from the cooperative, Dorothi constructed a poultry shed and began poultry farming in 2019. This venture significantly improved her family's financial situation. She now earns Rs. 8,000 to Rs. 9,000 per month from egg production, while her son works as a driver for the cooperative, earning Rs. 8,000 per month. Her husband has returned to the village and started a small carpentry business. This newfound financial stability has had a profound impact on the family's quality of life. Dorothi has been able to ensure that all her children receive a good education. Her eldest daughter has completed her BA and is working with a private institution, the second daughter is in her final year of BA, the third daughter is in 12th grade, and the youngest is in 9th grade. The income from poultry farming has also enabled them to build a new house and secure a better future.

Dorothi and her husband are committed to continuing their children's education and saving for the future. Dorothi also plans to continue working hard in poultry farming to support the cooperative and ensure good production for its members. Her dedication and the positive changes in her family's life underscore the significant impact of the cooperative initiative.
